A. Disclaimers

- ❖ The List of Covered Drugs and/or pharmacy and provider networks may change throughout the year. We will send you a notice before we make a change that affects you.

B. Reviewing your Medicare and Medicaid coverage for next year

It is important to review your coverage now to make sure it will still meet your needs next year. If it does not meet your needs, you may be able to leave the plan. Refer to section E2 for more information.

If you leave our plan, you will still be in the Medicare and Medicaid programs as long as you are eligible.

- You will have a choice about how to get your Medicare benefits (refer to pages 9-10).
- You will have a choice to get your Medicaid benefits through Medicaid fee-for-service, or a Medicaid managed care plan

NOTE: Effective January 1, 2023, if you're in a drug management program, you may not be able to change plans. See Chapter 5, Section G of your *Participant Handbook* for information about drug management programs.

B2. Information about PHP Care Complete FIDA-IDD Plan

- Partners Health Plan is a managed care plan that contracts with Medicare and the New York State Department of Health (Medicaid) to provide benefits to Participants through the Fully Integrated Duals Advantage for Individuals with Intellectual and Developmental Disabilities (FIDA-IDD) Demonstration.
- Coverage under PHP Care Complete FIDA-IDD Plan is qualifying health coverage called “minimum essential coverage.” It satisfies the Patient Protection and Affordable Care Act’s (ACA) individual shared responsibility requirement. Visit the Internal Revenue Service (IRS) website at www.irs.gov/Affordable-Care-Act/Individuals-and-Families for more information on the individual shared responsibility requirement.
- PHP Care Complete FIDA-IDD Plan is offered by Partners Health Plan. When this *Annual Notice of Changes* says “we,” “us,” or “our,” it means Partners



Health Plan. When it says “the plan” or “our plan,” it means PHP Care Complete FIDA-IDD Plan.

B3. Important things to do:

- **Check if there are any changes to our benefits that may affect you.**
 - Are there any changes that affect the services you use?
 - It is important to review benefit changes to make sure they will work for you next year.
 - Look in sections D and D1 for information about benefit changes for our plan.
- **Check if there are any changes to our prescription drug coverage that may affect you.**
 - Will your drugs be covered? Are they in a different tier? Can you continue to use the same pharmacies?
 - It is important to review the changes to make sure our drug coverage will work for you next year.
 - Look in section D2 for information about changes to our drug coverage.
- **Check if your providers and pharmacies will be in our network next year.**
 - Are your doctors, including your specialists, in our network? What about your pharmacy? What about the hospitals or other providers you use?
 - Look in section C for information about our *Provider and Pharmacy Directory*.
- **Think about whether you are happy with our plan.**

If you decide to stay with 2023 PHP Care Complete FIDA-IDD Plan:

If you want to stay with us next year, it's easy – you don't need to do anything. If you don't make a change, you will automatically stay enrolled in our plan.

If you decide to leave 2023 PHP Care Complete FIDA-IDD Plan:

If you decide other coverage will better meet your needs, you may be able to switch plans (refer to section E2 for more information). If you leave our plan, your new coverage will begin on the first day of the following month. Look in section E2, pages 7-8 to learn more about your choices.

C. Changes to the network providers and pharmacies

We have not made any changes to our network of providers and pharmacies for next year.

However, it is important that you know that we may make changes to our network during the year. If your provider does leave the plan, you have certain rights and protections. For more information, refer to Chapter 3 of your *Participant Handbook*.

D. Changes to benefits for next year

D1. Changes to benefits for medical services

We are changing our coverage for certain medical services next year. The following table describes these changes.

	2022 (current year)	2023 (next year)
Over-the-Counter (OTC) Flex Card	OTC Flex Card is not covered.	PHP will add an OTC Flex benefit for eligible participants. This will be a monthly benefit of \$150 allowance that helps you cover out-of-pocket expenses on approved health products, healthy grocery items, fresh produce, and healthy prepared meals. Items can be obtained from participating retail locations, or you may get home delivery options when you order online, by phone or by mail.

Changes to our Drug List

We have not made any changes to our Drug List for next year. However, we are allowed to make changes to the Drug List from time to time throughout the year, with approval from Medicare and/or the state. Refer to the 2023 Drug List for more information.

E. How to choose a plan

E1. How to stay in our plan

We hope to keep you as a Participant next year.

You do not have to do anything to stay in your health plan. If you do not sign up for a Medicare Advantage plan or change to Original Medicare, you will automatically stay enrolled as a Participant of our plan for 2023.

E2. How to leave PHP Care Complete FIDA-IDD Plan

You can end your participation at any time during the year. You will return to getting your Medicare and Medicaid services separately as described below.

You have three options for getting your Medicare services. By enrolling in one of these options, you will automatically end your participation in PHP Care Complete FIDA-IDD Plan.

If you leave PHP Care Complete FIDA-IDD Plan, you will still be able to get your Medicaid services.

- You will get your long-term services and supports and your Medicaid physical and behavioral health services through Medicaid Fee-for-Service.
- You can use any provider that accepts Medicaid.

Your 2023 Participant Handbook

The *2023 Participant Handbook* is the legal, detailed description of your plan benefits. It has details about next year's benefits. It explains your rights and the rules you need to follow to get covered services and prescription drugs.

F2. Getting help from New York Medicaid Choice

New York Medicaid Choice is New York State's managed care enrollment broker. New York Medicaid Choice counselors can tell you about your other options. F3. Getting help from the Independent Consumer Advocacy Network (ICAN)

ICAN is an ombudsman program that can help you if you are having a problem with PHP Care Complete FIDA-IDD Plan. ICAN's services are free.

- ICAN is an ombudsman program that works as an advocate on your behalf. They can answer questions if you have a problem or complaint and can help you understand what to do.
- ICAN makes sure you have information related to your rights and protections and how you can get your concerns resolved.

HIICAP counselors can help you understand your choices and answer questions about switching plans. HIICAP is not connected with us or with any insurance company or health plan.
